Bidding will be conducted in accordance with the Open Domestic bidding procedures contained in the Government of Uganda's Public Procurement and Disposal of Public Assets Act, 2003 and is open to all bidders from eligible source countries. **Exclusive reservation by threshold to local providers shall apply.**
- 4. Interested eligible bidders may obtain further information and inspect the bidding documents at the address given below at 8(a) from 8:00am to 5:00pm during official working hours.
- 5. The Bidding documents in English may be purchased by interested bidders on the submission of a written application to the address below at 8(a) and upon payment of a non-refundable fee of **UGX 100,000/=** (**Uganda Shillings One Hundred Thousand Only**). The method of payment will be by bank advice form which may be obtained from the URA WEBSITE/ OFFICES. Payment can be made in any bank and the payment details presented to the Procurement and Disposal Unit before obtaining a copy of the bidding document. No cash will be accepted.
- 6. Bids must be delivered to the address below at 8(a) at or before 10:00am on 26th September, 2019. All bids must be accompanied by a bid security in form of an unconditional bank guarantee amounting to (as indicated in the table above valid until 24th April, 2020). Late bids shall be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below at 8(b) at 10:30am on 26th September, 2019.
