The Ministry of Water and Environment has allocated funds for Supply of assorted quality tree and Bamboo seedlings across the country as follows; Lot 1: Mubuku irrigation scheme catchment one and neighbouring areas, Lot 2: Mubuku Irrigation Scheme Catchment Two and Neighbouring Areas, Lot 3: Agoro Irrigation Scheme Catchment and the Neighbouring Areas, Lot 4: Doho 1 Irrigation Scheme Catchment and the neighbouring areas, Lot 5: Doho II irrigation scheme catchment and the neighbouring areas, Lot 6: Olweny Irrigation Scheme Catchment and the Neighbouring Areas, Lot 8: Ngenge Irrigation Scheme Catchment and the Neighbouring Areas, Lot 9: Mt. - 2. The Entity invites sealed bids from eligible suppliers for the provision of the above supplies.
- 3. Bidding will be conducted in accordance with the Open Domestic Bidding method contained in the Government of Uganda's Public Procurement and Disposal of Public Assets Act, 2003.
- 4. Successful bidders should not have conflict of interest in relation to the subject of the procurement, should not be suspended by PPDA, and must demonstrate legal capacity to contract.

- 6. A complete set of bidding documents may be purchased by interested bidders on the submission of a written application and upon payment of a non-refundable fee of Ushs. 100,000 (One Hundred Thousand Uganda Shillings only) payable to the Bank after obtaining the Bank slips.

Bids will be opened in the presence of the bidders or their representatives who choose to attend at the address below at 7 (d) on 9th January, 2020 at 11:30am and must be accompanied by a bid security in form of a bank guarantee of Ushs 30,000,000 (Uganda Thirty Million only).
