The method of payment will be by bank advice form which may be obtained from the URA Website/ Offices. Payment can be made in any bank and the payment details presented to the Procurement and Disposal Unit before obtaining a copy of the bidding document. No cash will be accepted.

All bids must be accompanied by a bid security in form of an unconditional bank guarantee amounting to UGX 8,000,000= (Uganda Shillings Eight Million Only).
