1. The Government of Uganda represented by Ministry of Water and Environment under the Rural Water Supply and Sanitation department has allocated funds to be used for the acquisition of works for the Extension of the Rural Water Supply Systems for Five Rural Growth Centers in L. Kyoga Basin namely:-Kyanvuma, Kasassira, Kameke, Nambale and Kapala.
2. The Entity now invites sealed bids from eligible bidders for provision of the above works;
3. Bidding will be conducted in accordance with the Open Domestic bidding procedures contained in the Public Procurement and Disposal of Public Assets Act, 2014, and is open to all bidders.
4. Interested eligible bidders may obtain further information and inspect the bidding documents at the address given below at 8(a) from **08:30a.m to 05:00 P.M on working days**
5. The Bidding Documents in English may be purchased by interested bidders upon submission of a written application to the address below at 8(a) and upon payment of a non-refundable fee of **UGX 100,000/- (Uganda Shillings One hundred thousand only)**. The method of payment will be by bank advice form that may be obtained from the Accounts Section at the Ministry of Water and Environment. Payment can be made in any bank and the payment details presented to the Procurement and Disposal Unit.
6. Bids must be delivered to the address below at 8(a) at or before **10:30am on 12th November 2020**. All bids must be accompanied by a bid security of UGX 60,000,000 (Uganda shillings Sixty Million). Bid securities must be valid until 20th April 2021. Late bids shall be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below at 8(a) at **11:00a.m 12th November 2020**.
