- 7. All bids must be accompanied by a Bid Security as follows:
 - (i) LOT 1: UGX 217,000,000 (Uganda Shillings: Two Hundred Seventeen Million) or its equivalent in freely convertible currency acceptable to the Employer.
 - (ii) Lot 2: UGX 385,000,000 (Uganda Shillings: Three Hundred Eighty Five Million) or its equivalent in freely convertible currency acceptable to the Employer.
 - (iii) Lot 3: UGX 64,000,000 (Uganda Shillings: Sixty Four Million) or its equivalent in freely convertible currency acceptable to the Employer

For Bid Securities issued by financial institution located outside the Employer's Country, the issuing financial institution shall have a correspondent financial institution located in the Employer's Country to make it enforceable.
