- 1. Government of Uganda through Ministry of Water and Environment, has received funds from the Germany Government through KFW to be used for the acquisition of Construction of Okokoro Rural Growth Centre Piped Water Supply Systems and Sanitation Facilities.

- 3. Bidding shall be conducted in accordance with the procedures contained in the Public Procurement and Disposal of Public Assets Act, 2003 (the Act) and the Regulations made under the Act and is open to all bidders.
