2. The Entity now invites eligible consultants to submit sealed expressions of interest to **Conduct Consultancy Services as indicated in the table below;**

3. Description of the Services for
 - Planning and mobilization and management arrangement include;
Community mobilization, sensitisation, capacity building and Household Surveys (Baseline, sanitation follow, socio- economic, customer satisfaction and post construction surveys) for towns under the districts in Water and Sanitation Development Facility - Central areas of operation.

Lot 1: Central Region districts include; **Nakaseke, Luwero, Mityana, Masaka, Mpigi, Mukono, Buikwe, Kayunga, Wakiso, Buvuma, Gomba, Butambala, Bukomansimbi, Kalungu and Lwengo.**

Lot 2: Midwestern Region districts include; **Hoima, Buliisa, Masindi, Nakasongola, Kiryandongo, Kyankwanzi, Kibaale, Kagadi, Kakumiro, Kiboga, Mubende, Kassanda and Kikuube.**

- Drama Shows for community mobilization will include;
Mobilizing the community for the shows, preparing (design and provide) a good stage for the show, stage/acting plays in towns, conducting question and answer session at different interludes of the plays.

Key messages for the Drama shows can be summarised as:

Water Supply, Sanitation, Hygiene improvement and environmental catchment protection, operation and maintenance of water supply, mobilization activities for Water Supply Projects.

- a) Lot 1: Central Region towns include: **Busiika, Bamunanika town, Bugema in Luweero District, Kakunyu and Kayindi in Buikwe, Kiwoko Town council in Butalangu, Nakaseke District, Butenga town and Kawoko town in Bukomasimbi District.**
 - b) Lot 2: Midwestern Region: **Kagadi Town Council, Muhooro town council, Kyenzigye town council and Ruteete Town Board in Kagadi district, Kikandwa sub county in Kasanda district, KasambyaTown Council in Mubende district Kyankwanzi town council, Butemba town, Bukwiri town, Nalukolongo town and Lusozi town in Kyankwazi district.**
4. Interested consultants should provide information demonstrating that they are eligible and possess the required qualifications to perform the services supported with relevant documentation.
 5. The short listing criteria will include: **Information indicating that the Consultant or service provider is eligible and qualified to perform the services (Valid trading license, Certificate of Incorporation, current income tax clearance, company form 7 or equivalent, Corresponding CVs and experience in at least two similar assignments).**
 6. Consultants may associate with other firms in the form of a joint venture to enhance their qualifications. The form of association, where applicable, should be indicated in the Expression of Interest.
 7. Preference schemes shall apply when evaluating Request for Proposals from the shortlisted consultants.
