INVITATION TO BID UNDER OPEN DOMESTIC BIDDING

INVITATION TO BID FOR PROCUREMENT OF A GEOPHYSICAL SURVEY EQUIPMENT
PROCUREMENT REF. NUMBER: MWE/SUPLS/19-20/00003

1. The Ministry of Water and Environment has allocated funds for Supply of a Geophysical Survey Equipment.
2. The Entity invites sealed bids for the provision of the above supplies.
3. Bidding will be conducted in accordance with the Open Domestic Bidding method contained in the Government of Uganda's Public Procurement and Disposal of Public Assets Act, 2003.
4. Successful bidders should not have conflict of interest in relation to the subject of the procurement, should not be suspended by PPDA, and must demonstrate legal capacity to contract. Bidders should also provide evidence of being a local provider. "Local provider" means a provider registered in Uganda whose majority ownership is held by Ugandan citizens. Documents to be submitted in the bid as proof of eligibility to be a local provider include; Return of Allotment of Shares; and copies of the national identity cards or passports of the majority shareholders.
5. You may obtain further information from the Entity and inspect the bidding documents at the address given below at 7 (a) from 08:00 AM TO 05:00 P.M.
6. A complete set of bidding documents may be purchased by interested bidders on the submission of a written application to the above and upon payment of a non-refundable fee of Ushs. 100,000 (One Hundred Thousand Uganda Shillings only) payable to the Bank after obtaining the Bank Advisory form.
6. Bids must be delivered to the address below at 7 (c) at or before **28th November, 2019 at 11:00am**. Late bids shall be rejected. Bids will be opened in the presence of the bidders or their representatives who choose to attend at the address below at 7 (d) on **28th November, 2019 at 11:20am** and must be accompanied by a bid security in form of a bank guarantee of Ushs 6,000,000 (Uganda Shillings Six Million only).
