1. The Ministry of Water and Environment –Water for Production Regional Centre North has allocated/received funds Government of Uganda to be used for the acquisition of Procurement of a Contractor for Weed Removal at Leye Dam in Kole.
2. The Entity invites sealed bids from eligible bidders for the provision of the above works.
3. Bidding shall be conducted in accordance with the procedures contained in the Public Procurement and Disposal of Public Assets Act, 2003 (the Act) and the Regulations made under the Act and is open to all bidders.
4. Interested eligible bidders may obtain further information and inspect the bidding document at the address given below at 8(a) from **8:00am to 5:00pm**.
5. The bidding document which has been prepared in the English language may be purchased by interested bidders at 8(b) upon payment of a non-refundable fee of **UGX: 100,000= Uganda Shilling One Hundred Thousand Only**. The method of payment will be To **Uganda Revenue Authority**.
6. Bids must be delivered to the address below at 8(c) at or before **10:00am**. All bids must be accompanied by a bid security of **UGX: 10,000,000= (Uganda Shillings Ten Million)**. Bid securities must be valid until **10th January 2022**. Late bids shall be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below at 8(d) at **10:30am**.
