The Government of Uganda has received loan financing from the African Development Fund towards the cost of Water Supply and Sanitation Programme – Phase II, and intends to apply part of the agreed amount for these loans to payments under the contracts for consultancy for the preparation of the water and environment Sector Performance Report for the year 2019/2020. The services under this consultancy shall include:

- a) Consider recommendations, issues and concerns raised on last year's sector performance report (SPR 2019)
- b) Plan the preparation of the SPR 2020
- c) Review respective sub-sector inputs (Mini-Reports) to the SPR 2020
- d) Prepare and present progress on the compilation of SPR 2020
- e) Integrate and incorporate stakeholders' comments into the SPR 2020
- f) Finalize the consolidated SPR 2020

The preparation of the SPR 2020 will be based on draft inputs from the various departments/directorates of the Ministry of Water and Environment (Directorate of Water Development, Directorate of Water Resources Management, Directorate of Environment Affairs); and its semi-autonomous agencies (, National Environment Management Authority, National Water and Sewerage Corporation, National Forestry Authority, Uganda National Meteorological Agency; and Non-Governmental Organisations in the water sector (Uganda Water and Sanitation Development NGO Network, and Environment & Natural Resources Civil Society Network) represented by Environmental Alert.

Specifically, the services to be provided under this consultancy are also intended to enhance the existing cooperation and coordination between the Water and Sanitation Sub-Sector (WSS) and the Environment & Natural Resources (ENR) sub-sector to ensure harmony and synergy.

The Ministry of Water and Environment now invites individual Consultants to indicate interest in providing these services. Interested Consultants must provide information indicating that they are qualified and have experience to perform the services (i.e. brochures, description of similar previous assignments, experience in similar conditions preferably within Uganda, availability of appropriate skills etc).

Eligibility criteria, establishment of the short-list and the selection procedure shall be in accordance with the African Development Bank's "Rules and Procedures for the use of Consultants" May 2008 Edition, which is available on the Bank's website at http://www.afdb.org.
