Government of Uganda has received financing from the World Bank towards the cost of the Irrigation for Climate Resilience Project (ICRP) and intends to apply part of the proceeds for Consulting services for Undertaking HIV/AIDS/COVID 19 Mainstreaming for the Matanda Irrigation Scheme in Kanungu District.

The consulting services ("the Services") include; (i) carry out an assessment of HIV/AIDS and Covid 19 risk in the Project area, (ii) Develop HIV/AIDS and Covid 19 Action Plan (iii) Develop, translate and disseminate HIV/AIDS and COVID 19 IEC Materials, (iv) Mobilize and raise awareness to beneficiary community on the causes, prevention and mitigation strategies of the HIV/AIDS and COVID 19, (v) encourage Voluntary Counseling and Testing (VCT) of farmers and community members in the project area, (vi) Develop linkages with the nearby health facilities for complicated cases or for technical support and monitor and evaluate the HIV/AIDS activities.

The implementation period of the assignment is 24 calendar months.

The Ministry of Water and Environment (MWE) now invites eligible firms to indicate their interest in providing the services. Interested consultants should provide sufficient information demonstrating that they have the required qualifications and relevant experience to perform the services. The shortlisting criteria are;

- 1. Minimum of five years' experience in the HIV/AIDS engagement during project implementation support activities for communities with demonstrable working experience in irrigation schemes activities, water for Production implementation activities and IEC development and dissemination experience in Uganda.
- 2. Submit the firms' organogram to demonstrate the firms' technical and managerial capacity.

- 3. The firm must demonstrate they have successfully implemented at least two similar assignments in Uganda with tasks or components related to implementation support for irrigation schemes and water for production facilities of similar local nature.
- 4. The firm must demonstrate the availability of personnel with appropriate qualifications, skills/expertise in following areas; Social Development, HIV/AIDS and Community Mobilization (Team Leader/Project Manager, Social Development Specialist, HIV/AID Specialist and Community liason officers. Please do not submit CVs and bio data of experts at this stage.

In the case of a joint venture, all the partners in the joint venture shall be jointly and severally liable for the entire contract, if selected.
