The Republic of Uganda has received financing from the World Bank towards the cost of the Integrated Water Management and Development Project (IWMDP) and it intends to apply part of the proceeds toward payments under the contract for Construction of Nyamugasani Water Supply and Sanitation System in Two (2) lots.
2. The Ministry of Water and Environment now invites sealed Bids from eligible Bidders for the works for Construction of Nyamugasani Water Supply and Sanitation System in Two (2) lots.
