### RECRUITMENT OF ENVIRONMENTAL RISK MANAGEMENT SPECIALIST TO SUPPORT INVESTING IN FORESTS AND PROTECTED AREAS FOR CLIMATE SMART DEVELOPMENT PROJECT (IFPA-CD)

The Government of Uganda has received financing from the World Bank towards the cost of the Investing in Forests and Protected Areas for Climate Smart Development (IFPA-CD) Project and intends to apply part of the proceeds for **Recruitment of an Environmental Risk Management Specialist**

The project is being implemented by the Ministry of Water and Environment (MWE -Lead Agency), Uganda Wildlife Authority (UWA) and National Forest Authority (NFA) with the involvement of the Ministry of Tourism, Wildlife and Antiquities (MTWA) in tourism-related activities.

The Project Development Objective (PDO) is to improve sustainable management of forests and protected areas and increase benefits to communities from forests in target landscapes.

The assignment shall be for a period of two years subject to probation period of six months, and is renewable subject to satisfactory performance.
