- 1. The Ministry of Water and Environment has allocated funds for Procurement of a provider for Servicing and Preventive Maintenance of Laboratory Equipment; Lot 4 General Laboratory Equipment and Generator.
- 2. The Entity invites sealed bids for the provision of the above Services.
- 3. Bidding will be conducted in accordance with the Open Domestic Bidding method contained in the Government of Uganda's Public Procurement and Disposal of Public Assets Act, 2003.
- 4. Successful bidders should not have conflict of interest in relation to the subject of the procurement, should not be suspended by PPDA, and must demonstrate legal capacity to contract.

- 6. A complete set of bidding documents may be purchased by interested bidders on the submission of a written application to the above and upon payment of a non-refundable fee of Ushs. 100,000 (One Hundred Thousand Uganda Shillings only) payable to the Bank after obtaining the Bank Advisory form.
- 7. Bids must be delivered to the address below at 8 (c) at or before 24th June 2021 at 11:00am. Late bids shall be rejected. Bids will be opened in the presence of the bidders or their representatives who choose to attend at the address below at 8 (d) on 24th June 2021 at 11:30am and must be accompanied by a bid securing declaration in a format.
