It is intended that part of the proceeds of this loan will be applied to eligible payments under the contract for Procurement of 5No Farm Tractors and Assorted Tractor Implements for the 5 irrigation schemes of Wadelai in Nebbi/Pakwach District, Tochi in Oyam District, Mubuku II in Kasese District, Doho II in Butaleja District and Ngenge in Kwen District under FIEFOC 2 Project.

The money will be paid to the bank with the bank slips obtained from the Ministry of Water and Environment Accounts Section. No cash will be accepted.

The provisions in the Instructions to Bidders and in the General Conditions of Contract are the Provisions of the African Development Bank's Standard Bidding Document for Procurement of Goods. Bids must be delivered to Procurement and Disposal Unit, Ministry of Water and Environment *Kabalega Crescent Road, Luzira, Kampala on or before* **11:00 am on 31**st **August 2021** and must be accompanied by a bid security in form of a bank guarantee worth Thirty Million shillings only (**Ugx 30,000,000).** Bids must remain valid for 120 days after the deadline for submission prescribed above
