The method of payment will be by Bank Payment Advice Form obtainable from the Uganda Revenue Authority (URA) website using "Other NTR" as a tax head in the form. - 6. Bids must be delivered to the address below on or before 11:00 am Ugandan time on Tuesday, 28th December 2021. Electronic bidding will not be permitted. Late bids will be rejected. Bids will be publicly opened in the presence of the bidders' designated representatives and anyone who chooses to attend at the address below at 11:10 am Ugandan Time on Tuesday, 28th December 2021.
- 7. All bids must be accompanied by a Bid Security per lot.
 Lot 1 bid security is of USD 15,000 or the equivalent amount in freely convertible currency acceptable to the Employer.
 Lot 2 bid security is of USD 2,700 or the equivalent in freely convertible currency acceptable to the Employer.

For Bid Securities issued by financial institution located outside the Employer's Country, the issuing financial institution shall have a correspondent financial institution located in the Employer's Country to make it enforceable.
